

The Graduate Diploma in English and Hong Kong Law and LLB (Hons) Hong Kong of Manchester Metropolitan University is almost the only package of programmes which covers all the Hong Kong and English law subjects currently needed to progress towards legal practice in both Hong Kong and England & Wales.

Study part-time for just two years and you will receive a *Graduate Diploma in English and Hong Kong Law* and be eligible to continue directly to professional legal training courses in England & Wales. Add on an optional third year part-time and you will get an *LLB (Hons) Hong Kong* and the chance to apply and see if you can join the many graduates of this course who have been successfully admitted to the PCLL without the hassle of having to sit a large number of extra conversion exams.

With thousands of alumni in Hong Kong, no other law programme of this kind offers such a wide range of career paths. That is why, for three decades, the *Graduate Diploma in English and Hong Kong Law* has been the most popular part-time route towards legal practice in Hong Kong.

BECOME A LAWYER IN ENGLAND & WALES

As an English law qualification, the *Graduate Diploma in English and Hong Kong Law* also gives you a recognised pathway towards legal practice in England & Wales after just two year's part-time study. You can continue directly to either the Legal Practice Course (LPC) or the Bar Professional Training Course (BPTC) for intending solicitors and barristers, respectively, at Manchester Metropolitan University and many other English universities. (Students taking the Bar route will need at least a second class degree, IELTS test result of 7.5 or above and must meet the requirements of the Bar Standards Board). After completing the BPTC, students taking the Bar route can be called to the Bar in England & Wales and use the title of Barrister when not providing legal services. However you will need to complete a legal traineeship before you can qualify to practice as a solicitor or barrister in England & Wales and provide legal services.

MORE CAREER PATHWAYS

While the *Graduate Diploma in English and Hong Kong Law* is widely prized as a unique fast track to legal practice, every year we also receive hundreds of applications from students seeking to advance their career prospects in business, compliance and many other industries where legal knowledge is an integral part of job duties.

The *Graduate Diploma in English and Hong Kong Law* provides a fast track to advanced legal studies as it allows you to proceed directly to a wide range of LLM programmes (if you have a second class degree or above), including those offered by The University of Hong Kong, City University of Hong Kong and the University of London part-time external programme.

WHAT WILL I STUDY?

Teaching on both the *Graduate Diploma in English and Hong Kong Law* (GDEHKL) and *LLB* (Hons) Hong Kong is closely tailored to meet the requirements for entry to both the PCLL and English legal training programmes:

GDEHKL YEAR 1

Full Modules:

- · Contract Law
- Law of Tort
- Public Law

Half Modules:

- · Hong Kong Legal System
- · European Union Law

GDEHKL YEAR 2

Full Modules:

- Criminal Law
- Equity and Trusts
- Land Law
- Hong Kong Land Law and Hong Kong Constitutional Law

LLB (OPTIONAL YEAR 3)

Full Modules:

- · Law of Hong Kong Evidence
- · Business Associations
- Commercial Law

Half Modules for PCLL Applicants:

- Hong Kong Civil Procedure
- · Hong Kong Criminal Procedure

Half Modules for non-PCLL Applicants:

- Family Law
- Legal Technology

Unlike most other English law courses, this three-year programme covers all the law subjects currently required for entry to the PCLL.

Year 1 classes begin in September with an introduction to English Legal System and a short test (which students must pass to continue to the other subjects). This is followed by a comprehensive package of lectures, tutorials and study skills sessions in the modules listed above, all taught at HKU SPACE in partnership with Manchester Metropolitan University.

For most of the academic year, students will generally be required to attend 2-3 classes per week. Students on the *Graduate Diploma in English and Hong Kong Law* will also have 24/7 online access to lectures in the same English law subjects delivered in Manchester.

Students will be given extensive assistance in preparing for the exams through a comprehensive programme of revision classes, which are usually taught by lecturers affiliated with Manchester Metropolitan University.

Teaching on the *LLB (Hons) Hong Kong* follows a broadly similar format, with some variations. For further information, please visit http://hkuspace.hku.hk/prog/llb-mmu

To help prepare for the PCLL, students on the *LLB (Hons) Hong Kong* will normally study half modules in Hong Kong Civil Procedure and Hong Kong Criminal Procedure. Those not planning to apply for the PCLL may instead choose half modules in Family Law and Legal Technology (subject to student demand).

Students are expected to attend at least 70% of all classes each year, but this requirement only applies to their average attendance across the whole academic year.

EXCELLENT RESULTS

Although academic standards are high, previous students have achieved outstanding results thanks to our excellent teaching record:

81% pass rate

LLB (OPTIONAL YEAR 3)

98% pass rate, with 64% of all students being awarded an Upper Second (2:1) or above

Modules are assessed by exams or coursework, with shorter assessments for most half modules. Exams are held at various points in the academic year, with most exams in May/June followed by resit examinations in August.



FREE 24/7 ONLINE ACCESS TO LECTURES FROM UK

Students on the *Graduate Diploma in English and Hong Kong Law* also benefit from 24/7 online access to more than 100 hours of lectures on the same English law subjects as students studying in the United Kingdom.

Online access to lectures from the UK is usually available for English law subjects on the *Graduate Diploma in English and Hong Kong Law*. As such, you can benefit from both the extensive tuition package in Hong Kong plus 24/7 online access to more than 100 hours of additional lectures on the same subjects which are delivered by experienced lecturers in Manchester.

In addition to online lectures from the UK, you will have 24/7 access to course materials and past exam papers through two online portals - Manchester Metropolitan University's Moodle system and HKU SPACE's SOUL 2.0 e-Learning system.

All students also receive a free Reader's card allowing access to all of The University of Hong Kong libraries and many of the electronic resources inside those libraries.

As a graduate programme, you are normally expected to hold a Bachelor's degree or acceptable degree-equivalent. We also accept applications from mature students without a degree, including graduates of HKU SPACE's popular Advanced Diploma in Legal Studies. Students who have not completed their studies may apply, as long as they will graduate before the programme starts.

All applications for the *Graduate Diploma in English and Hong Kong Law* must be accompanied by the application fee and full supporting documents, which will normally include both your university degree certificate and full transcript. Students who successfully complete the *Graduate Diploma in English and Hong Kong Law* are normally guaranteed admission to the *LLB (Hons) Hong Kong* of Manchester Metropolitan University. For further information and an application form, please visit the Web page for the *LLB (Hons) Hong Kong*.

Both programmes are for those having the right to live and study in Hong Kong and it is the responsibility of applicants to determine if they are eligible. (Under current immigration rules, it is unlikely that any overseas applicants will be granted visas to study either programme.)
