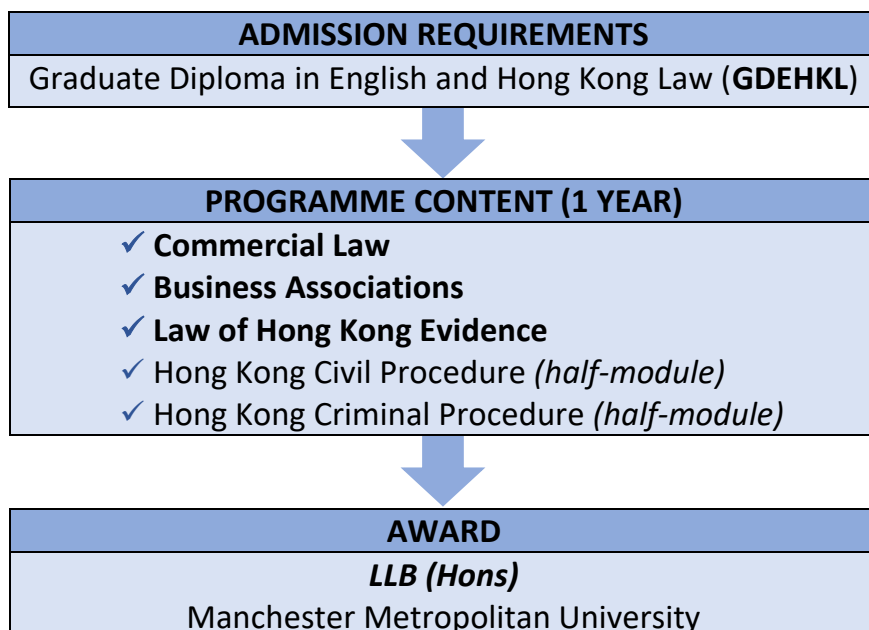

- This 1-year LLB top-up programme allows GDEHKL graduates to complete the 3 remaining prerequisite subjects for eligibility for entry to the PCLL programme, i.e. *Commercial Law*, *Business Associations* and the *Law of Hong Kong Evidence*

### ✓ **Obtain a law degree**

- By using this route to top up your GDEHKL, you can obtain the world-famous and much-coveted Bachelor of Laws (LLB) degree

### ✓ **Expand your legal knowledge**

- Even if you are not interested in pursuing the PCLL, this 1-year LLB top-up programme will allow you to expand your legal knowledge beyond the subjects studied on the GDEHKL and equip you with further legal skills and awareness, increasing your appreciation of law in the business and general life context

### ✓ **Gain a head-start on the PCLL programme**

- By studying the 2 half-modules of *Hong Kong Civil Procedure* and *Hong Kong Criminal Procedure*, you will gain a head-start over most of your future PCLL class peers who will only meet these two procedural subjects for the first time on the PCLL programme

Applicants should fill in the Application for Enrolment Form (SF26) – with both the original and a photocopy of their full degree transcript and certificate – to any HKU SPACE Enrolment Centre. ## Course Fees
