About the Programme



BSc (Hons) Accounting programme aims to provide students with a thorough knowledge and understanding of both the philosophy and functions of accounting. Students will acquire practical skills relating directly to the subject and a range of transferable skills that will become valuable assets in accounting or business organisations.

The entire programme comprises 18 modules or 360 credits. Students are required to take 120 credits' worth of modules each year and may normally complete the entire programme in three years of full time study in the UK, but in Hong Kong, only the Second Year and Final Year modules are offered.



Students with the required qualifications, such as the Advanced Diploma, Higher Diploma and Associate Degree major in Accounting approved by Hull University Business School, are qualified for direct admission to the Second Year of the programme, and are required to complete nine modules for graduation (180 credits).

This is a non-credit-bearing course, and grades will not be counted towards the final award.

Professional Recognition



Graduates of the programmes will be eligible for exemption from the Professional Examinations of the ACCA.



BSc (Hons) Accounting meets the educational requirements of CPA Australia. Upon completion of the programme and meeting CPA Australia's core knowledge requirements, graduates can become Associate Members of CPA Australia. To advance to the qualified CPA Australia status, candidates will need to complete the Professional Level of the CPA Programme, which incorporates six postgraduate education segments and three years of practical experience.



Graduates of this programme will be eligible to enrol the Qualification Programme (QP) offered by HKICPA.

Mode of Delivery

There will be three semesters in an academic year. Each module comprises 42 contact hours consisting of a combination of lectures and tutorials. The University of Hull teaching staff will conduct one 18-hour intensive teaching block supplemented by 18 hours of tutorials plus 6 hours drop-in sessions to be conducted by HKU SPACE lecturers.

Taxation (Hong Kong) and Business & Company Law (Hong Kong) will be taught by local lecturers.

Except for the Research Project, Auditing and Taxation (Hong Kong) module, assessment for each module will normally be based on coursework, written assignments and a final examination.

In addition, all students are required to undertake the Research Project on a topic of their choice in the final year. There will be no written examination for this module. Students will be assessed 100% by coursework comprising oral presentation and written report.

Entry Requirements

Applicants Shall Hold:

1. an Advanced Diploma / Higher Diploma / Associate degree in Accounting awarded within the HKU system through HKU SPACE with a GPA of 2.0 or its equivalent; **OR**
2. a related Higher Diploma or an Associate Degree offered by HKU SPACE or a Higher Diploma or an Associate Degree from other tertiary institutions in the areas of accounting recognised by The University of Hull.

For 1. above, applicants holding a related Advanced Diploma shall preferably have 2 years of work experience.

Graduates of the HKU SPACE Advanced Diploma / Higher Diploma / Associate Degree programmes recognised by The University of Hull are considered to have met the English requirement. In other cases, applicants should have proof of English proficiency by having:

- i. a Grade E in the Use of English in Hong Kong Advanced Level Examination (HKALE); **OR**
- ii. Hong Kong Diploma of Secondary Education (HKDSE) Examination with minimum score of overall level 4 in English Language (with a minimum of level 3 in each skill); **OR**
- iii. IELTS with a minimum score of overall 6.0 (with a minimum 5.5 in each skill); **OR**
- iv. Pearson Academic Test of English with minimum score of overall 54 (with a minimum 51 in each skill); **OR**
- v. recognised equivalent.

Applicants with other equivalent qualifications will be considered on individual merit.



Application

Applicants are required to complete the enclosed application form and submit together with the following fees and documents to any of our enrolment counters:

- A non-refundation \$200 Application fee;
- A certified true copy* of Hong Kong Identity Card ;
- One set of certified true copies* of hull education certificates and transcripts ;

*Original Certificates and transcripts together with the copies are required to be presented to any HKU SPACE Learning Centre for verification.
